DDDads Mission Statement: Our mission is get your sons & daughters home on weekends, with their own vehicles, safely.

1. Try to have **3 Designated Driver Dads** working together whenever possible. **Designated Driver Dads** drive the patron(s) home with the patron(s) in the back seat of their own vehicle. The other **Designated Driver Dad** follows behind in our vehicle at a safe distance behind the patrons lead car. Please have magnetic signs on the follow car sides to clearly mark our service is in operation.
2. **Designated Driver Dads** are **not** allowed to volunteer to drive within 24 hours of drinking alcohol in their personal time.
3. **Designated Driver Dads** must **not** do any illegal drugs at any time in their own personal time.
4. **Designated Driver Dads** must have a valid driver's license within that province with them before operating any patron's vehicle. (A valid business license from the local City Hall must be obtained first before operating under the name of **Canadian Designated Driver Dads Inc.**)
5. There are **no** mandatory schedules for **Designated Driver Dads** as this is strictly done on a volunteer basis only.
6. **Designated Driver Dads** are to initially make contact with the nightclubs, bars or house parties within the city that they are operating out of. **Designated Driver Dads** posters can be given to the doormen at each nightclub or bar to make potential patrons aware of our service. It is up to each nightclub or bar as to where the **Designated Driver Dads** service poster is to be placed. We suggest that the posters are hung within each washroom and at all exit doorways in full view with the phone number visible.
7. **Designated Driver Dads** typically drive to a nightclub, bar, or house party on any given Friday or Saturday night between the hours of **1:00 am & 3:00 am**. **Designated Driver Dads** gives the doormen some business cards with the cellular phone number of the head driver dad on it. **Designated Driver Dads** don't go into the bars or nightclubs or into a patron's home or apartment once they arrive there safely. Return the vehicle keys to the patron and ask if they would like to donate to the service.
8. **Designated Driver Dads** are to let the doormen, know that their service is available each time they arrive or return back to the nightclubs, or bars. The doormen can give out our business cards to anyone that they may view over the legal drinking limit if they want. **DDDads** Business cards are also handed out to anyone on the sidewalks. **Designated Driver Dads** simply wait for calls, through the head driver dad, or by those they meet outside the nightclubs or bars on the sidewalks.
9. **Designated Driver Dads** must verify that the patron's vehicle has proper insurance coverage with a current valid sticker on the license plate, before they agree to drive the patron(s) vehicle home for them.
10. **Designated Driver Dads** drive the patron(s) home in their own insured vehicle with another **Designated Driver Dad** following behind, in their own follow vehicle. If a patron looks like they may be experiencing a drug or alcohol overdose, then by all means take them to the hospital.
11. Verbal permission to operate the patron(s) vehicle **must** be asked for by the **Designated Driver Dad** prior to driving that patron(s) & their vehicle home safely. **DDDads** are to be as polite and helpful as possible, always displaying kindness and tolerance.
12. The head **Designated Driver Dad** will pay for any insurance deductible costs under the patron's vehicle insurance collision coverage, if an accident occurs while operated by a **Designated Driver Dad** from proceeds collected through **DDDads**. (Also **DDDads** we will cover the patron's car rentals until the damaged vehicle is returned to the patron.) Also If the damage is minor then **DDDads** will just pay for the repairs.
13. If the patron(s) vehicle is **not** properly insured then the **Designated Driver Dad** must **not** drive the patron(s) car home. The patron(s) is then responsible to get home some other way, as the service is designed to get patron(s) with insured vehicles home safe. The secondary option of just driving the patron(s) home is at the discretion of the head **Designated Driver Dads** discernment. (Remember,...we are not taxi service, but we are dads & we are out there to care for anyone that may be in a dangerous situation.) Our **DDDads** policy is as follows: **"one car to one location"** thus we **do not** taxi others around the city before we go to the final destination at the patron's home or apartment.
14. The head **Designated Driver Dad** decides for himself how the monies received can be re-donated, once the business expenses are covered. The cost of printing business cards, posters & T-shirts may be a part of donations from local business's that wants to support us financially.
15. The head **Designated Driver Dad** in each city is **solely** responsible to the Government of Canada, for any and **all taxes**, for any and all funds that are brought into his possession while operating under the corporate name, or corporate logo of **Canadian Designated Driver Dads Inc.** (We suggest that you keep any tax receipts of expenses that you may occur, and give out receipts for any the donations that you receive. Ask your local Chartered Accountant to donate their services to help you operate within your city each year as part of the **DDDads** team.)
16. **Canadian Designated Driver Dads Inc.** service is offered strictly on a "free will" donation basis by each patron. **Canadian Designated Driver Dads Inc.** will **never** be in competition with local taxi cab services. **Designated Driver Dads** should always direct the patron(s) to use taxi cab drivers if they do not have a vehicle with them. We strictly just want to give patrons an alternative choice to driving drunk from the bars or nightclubs on the weekends. Please honor all the local taxi services as that is their source of income.
17. Each potential **Designated Driver Dad** must agree with & sign off on all these 21 listed items prior to driving any patron(s) vehicle home under the corporate name or corporate logo of **Canadian Designated Driver Dads Inc.** (This sheet is to be printed off by the head **DDDad**, & you are to sign this page, and return it to the head **DDDad** for his corporate files and records.)
18. Potential **Designated Driver Dads** must provide a current driver's abstract & a criminal record check (available at any local police station) prior to participating in **Designated Driver Dads**. The information is to be sent to the address above for our **DDDads** records and for our final approval by the head **DDDad** overseeing in each city operating under **Canadian Designated Driver Dads Inc.** The cost of getting a drivers abstract, & a criminal record check is up to each potential volunteer **DDDad**.
19. **Canadian Designated Driver Dads Inc.** is a concept that can be reproduced in any Canadian community, if approval from **Canadian Designated Driver Dads Inc. and/or Paul Nesbitt** is received prior to using the corporate name, logo, business cards, posters or T-shirts.

20. Approval in writing from **Canadian Designated Driver Dads Inc. and/or Paul Nesbitt** must be applied for and secured prior to operating or using the corporate name, or logo of **Canadian Designated Driver Dads Inc.** (Contact Paul Nesbitt at: 250.862.6096 for details.)
21. The head **DDDad and/or Paul Nesbitt** operating as the owner or franchisee under the name or logo of **Canadian Designated Driver Dads Inc.**, within a city, reserves the right to withdraw endorsement, or refuse anyone the right of participation, **without any reason, at anytime**, while that person is applying or operating under the corporate name or corporate logo of **Canadian Designated Driver Dads Inc.**
